Texas Commission on Environmental Quality,

I am filing a motion to overturn the ED approval of Rock Crushing Plant on Hover Valley Road, Permit # 176835.

I am a business owner in Burnet and allowing the plant to have a permit would attack the air quality to two most vulnerable populations, elderly and young. I spoke at the public meeting, December 10, 2024, which we were told before the meeting started each person would have 3 minutes to speak at the microphone and just before the meeting started it was announced each person would only have 2 minutes to speak. At the meeting, I handed a study of air quality at signing in to speak (front of the church) and a second copy before I spoke at the microphone. No one from Texas Commission on Environmental Quality has contacted me about the study. I was told any study presented to TCEQ it would be reviewed and the person would be contacted by a person from TCEQ, that did not happen.

The TCEQ letter head of letter sent out is currently a lie. If the statement "Protecting Texas by

Reducing and Preventing Pollution” were upheld by TCEQ, TCEQ would have already said no to the permit. Asphalt Inc LLC will not reduce pollution it will multiply it. Asphalt Inc LLC will not prevent pollution it will be the cause of unnecessary, harmful pollution.

TCEQ should be looking out for Texas citizens first and not giving in to corporate industry invading citizens neighborhoods. The elderly cannot move, and the young have no choice, they live in Burnet with their families. Asphalt Inc LLC can move to another area not in a neighborhood.

TCEQ should protect Texas citizens, it is that simple, period.
